COOKIES AND SIMILAR TECHNOLOGIES

While you are browsing, cookies are stored on your device (computer, mobile phone, tablet), subject to the choice you have made and that you can change at any time by managing your settings (see "Accept or reject cookies").

Placed on your terminal when you visit a website, a cookie is a small text file containing information about your browsing (pages viewed, date and time of the consultation, etc.), whose main purpose is to enhance your visit and allow you to receive targeted services. The term "cookie" is hereafter referring to cookies, trackers, pixels and any other technologies.

Types of cookies

• Internal cookies required for the Website to operate

Test_cookie	Doubleclick.net: Used to check whether the browser of the visitor accepts cookies Expiration : 1 day

These cookies are strictly necessary to the functioning of the Website.

The personal data (unique ID identifier, IP address, information on user's equipment) is collected on the contract basis.

_hjIncludedInSample	HOTJAR: allows to study the behaviour of the user on the Legrand.com website. No personal data is stored Expiration: 13 months
atidvisitor	AT-INTERNET: used to record statistics about the internet user's equipment and browsing history (statistics) on the Legrand.com site. No personal data is stored. Expiration: 13 months
Hit.xiti Idrxvr	Legrand.com: Determines whether the user's behavioural pattern Expiration: session

The personal data collected is: unique ID identifier, IP address, information on user's equipment, activities performed on the Website: date of first and last visit / duration of visit / time of arrival and departure from the Website.

No nominal data is stored, and no statistical data is cross-referenced with any nominal data that the Legrand Group may have.

When you consent to the deposit of such cookies through our "cookies banner", this shall constitute the legal basis of the processing. You can decide to withdraw such consent at any time by following the procedure set out in the "Accept or refuse cookies" section.
